Who we are?

- COP network comprises **12 members** (7 ESF-MAs and 5 other Public Authorities or Technical Assistances) out of 9 MS:
 - AT Federal Ministry of Labour, Social Affairs and Consumer Protection (BMASK), ESF-MA, Centre for Social Innovation (ZSI)
 - BE(FI) ESF-Agency Flanders, ESF-MA
 - DE Ministry of Labour and Social Affairs, ESF-MA and gsub - Projektegesellschaft mbH
 - EL Ministry of Employment and Social Protection, ESF- MA
 - HU National Development Agency, ESF-MA and Ministry for National Economy
 - IE Pobal
 - PL “Cooperation Fund” Foundation
 - PT Human Potential Operational Programme, ESF-MA
 - RO Ministry of Labor, Family and Social Protection, ESF-MA

- Lead partner: Federal Ministry of Labour, Social Affairs and Consumer Protection (BMASK), Austria

- Since project start, the COP network stretched out from 10 Steering group members in January 2009 to **187 registered users** of the Web portal by 07 October 2011.



What are we interested in?

The COP focuses on the policy areas identified for ESF interventions, thereby examining **PEOs**:

- Partnership **Pactices** of MS on all levels,
- **Effects** on policies as well as impacts for ESF target groups and
- **Opportunities** for improving policy planning and delivery.

COP promotes continuous learning within the COP with the “**critical friend**” **review method**.

COP is interested in **partnership** in two forms:

- **governance mechanism** (ESF Reg., Art. 5);
- **territorial alliances/projects** (ESF Reg., Art. 3).



Partnership Practices of MS

Partnership as a governance mechanism (ESF Reg., Art. 5)

"The Member States shall ensure the involvement of the social partners and adequate consultation and participation of other stakeholders, at the appropriate territorial level, in the preparation, implementation and monitoring of ESF support"

Partnership in the form of territorial alliances / projects (ESF Reg., Art. 3)

"Promoting partnerships, pacts and initiatives through networking of relevant stakeholders, such as the social partners and non-governmental organisations, at the transnational, national, regional and local levels in order to mobilise for reforms in the field of employment and labour market inclusiveness"
